

# Children's Initiative gearing up for November ballot

The Children's Initiative #102 heads for the November ballot, with a majority approval rating among our state's voters in recent polls and the support of over 100 organizations and scores of elected officials. It is one of the broadest coalitions of people in our state ever to work for a ballot issue

We have six months to raise money, talk to our groups and do everything we can to get the word out to the rest of the voters that the Children's Initiative #102 is the only way to ensure a secure and certain source of funding for the health, protection and education of all of our children.

Jon LeVeque anticipates victory in November citing this state's strong tradition for enacting laws through initiative. Last year the voters overwhelmingly passed both the citizens' toxic cleanup and the minimum wage bills when the Legislature failed to act.

The House passed the Children's Initiative with bipartisan support and Governor Gardner endorsed #102. But a handful of State Senators, led by State Senator Linda Smith (R-Hazel Dell) vetoed the opportunity to pass the Children's Initiative last session. Washington State has been falling

## **On the Bestseller Lists**

What if ...?

What if on November 22, 1963, Lee Harvey Oswald and the other conspirators failed in Dallas and President John F. Kennedy survived the attempted assassination, critically injured and incapacitated?

What if the recuperating President, physically incapable of a strenuous 1964 re-election campaign, still was able to wield enough power to insure that his brother, Bobby, was given the Vice-Presidential nomination on the ticket with Acting-President Lyndon Johnson to run against a Republican nomination of Nelson Rockefeller and Barry Goldwater?

Whoa! Circle the wagons! Bring in J. Edgar Hoover, Fidel Castro, the Mob, the Vietnam War and a continued cover-up reaching the highest levels and you've got the story line of the book *Promises To Keep* by George Bernau, at your bookstores and elsewhere now. (Warner Books, paperback, \$5.95, 671 pages)

Promises to Keep is an intriguing story, fast paced, and an all around good read. At the start it is a bit contrived, as you try to get used to the abundant pseudonyms that the author found necessary to avoid lawsuits, but that passes soon. Kennedy is "President John Cassidy", Johnson is "Rance Gardner", Bobby is "Tim", Jackie is "Suzanne", Onassis is "Konstantine" and on and on. The only real name Bernau uses is Castro. (I guess he's not afraid of a libel suit there). After a hundred pages, though, you don't even read the names as they are written, but follow the story subconsciously substituting in the real ones.

Politics, intrigue, danger and its domestic and international ramifications all combine to propel the reader through page after page of a story so well set in an accurate depiction of events and details which we all remember that it blurs history and fiction.

If the story fails, it is probably in the perpetuation and expansion of the Camelot mythology, as the "fictional" Kennedys have few, if any, human faults. That, however, for the Democratic reader, might even be a positive aspect because when we think back, now twenty-five years, we do think:

"What if ...?"
