## Guenther Named LC Demo of the Year -- Judy, That Is

Lewis County Democrats honored Judy Guenther as the 1999 Lewis County Democrat of the year during the annual Jefferson-Jackson Day dinner last October. The award, which recognizes the individual in Lewis County who has contributed the most to the efforts of the party during the year, is the highest award conferred by the Lewis County Democratic Central Committee.

Ed Smethers, who presented the award to Judy, was part of a well planned "conspiracy" to surprise Judy with her award. The conspiracy worked to perfection. Judy was virtually speechless in accepting the award.

Smethers, in his presentation remarks, said "Some years the choice of Lewis County Democrat of the year has been a difficult choice to make. That was not the case in 1999, and the unanimous choice was Judy Guenther."

Smethers continued by saying: "Besides co-hosting the annual salmon bake, working on our auction, the J.J. Dinners, and the fair booth, she did something very few other people would do. She opened her home for five months and provided housing for two young fellows who worked on both local and the congressional campaigns."

Judy is presently the Forest Precinct Committee Officer for the Lewis County Democratic Central Committee.

Besides her full involvement in party functions, Judy also dedicates a great deal of time to the betterment of the community as a whole. She was appointed by the Governor to the Centralia College Board of Trustees, which she now chairs. She is currently president of the Lewis County Community College Trustees Association.

Judy is a board member of both the United Way of Lewis County and of the Lewis County Crime Stoppers.

Ed Smethers concluded his presentation by stating: "Above all that, she must be commended for her support and understanding of her husband, Bob, who chairs the Lewis County Democrats."

## Team Work Works

Prior to the October State Committee meeting that was held in Bellingham, citizens of the county and Randle had done a lot of work about their concerns with the land swap between Plumb Creek Timber and the U.S. Forest Service.

Citizens of Randle rallied around the committed people of the Cascadia Defense Network in the peaceful protest to the Watch Mountain portion of the land swap. The people of Randle were concerned about flooding and land slides raising havoc in their community, if this property didn't remain public property maintained by the Forest Service.

The citizens formed a lobbying group, which went to our nation's capitol to let the federal legislators know their issues. The efforts and personal expense expended by the folks should be greatly appreciated. Some of this group also traveled to San Francisco to attend the Sierra Club's national board of directors meeting. The lobbying group and many others attended a peaceful opposition demonstration in Seattle.

Our congressman, Brian Baird, spoke directly to the concerned citizens in Randle during one of his town hall meetings (one of 60 held in the 3rd District this year) and also hosted the lobbying group in Washington, D.C. After examining the information presented, Brian Baird took up the fight for his constituents. Congressman Baird's persistence on this matter is on the record.

U.S. Senator Patty Murray sent two of her staff folks to Randle to listen to the concerns of the citizen's committee. Senator Murray's response to those concerns deserves a thumbs up.

The Lewis County Democratic Central Committee held its annual meeting in Randle (Red Rogers Run to Randle) in September. The outcome of the meeting was a decision to present a resolution to the October State Democratic Committee meeting in Bellingham voicing our organization's opposition to the land swap. The resolution passed without any opposition at the state level.

The result of the effort put forth by all of the people involved made a positive difference not only for the people of East Lewis County, but for all of us who will forever be able to enjoy the Watch Mountain area. Congratulations to the people of Randle for their persistence.

## Introducing Brian Sonntag, Washington State Auditor

Brian Sonntag serves as our state's eighth elected State Auditor. Brian was first elected to this office in 1992, and was re-elected in 1996. He received the highest vote total of all our candidates in 1996, and is a strong part of our Democratic team.

Sonntag served in elected office in Pierce County before running and winning statewide. Brian was elected Pierce County Clerk when he was 26 years old and served eight years in that office. He was twice elected to the position of Pierce County Auditor, an office his father had held for 22 years. Brian's experience in local and state government is extensive, and his roots in the Democratic Party are deep.

Brian Sonntag has always advocated for an open, responsive government that encourages citizen participation.

Brian has been supporting an effort to create a Citizens Alliance that would provide a system to make sure government is listening to citizens. Brian first shared this idea with the Governor and Legislature last fall. There has been support for this effort coming from across the state.

Brian, who has been a frequent visitor to Lewis County Democratic Party functions, is a Certified Government Financial Manager, is a member of a national ethics organization, and chairs Public Service Recognition Week.

## Congressman Baird Reports

Since I was sworn into office last year, I have made it my top priority to listen -- really listen -- to the concerns and ideas of the folks who sent me to represent them in Congress. I have visited schools, hospitals, businesses, senior centers, union halls, ports, transportation projects and talked to hundreds of folks in Lewis County and other parts of Southwest Washington. I've ridden along with sheriffs and firefighters and hosted nearly 60 town meetings -- one in every incorporated town in the district. These activities have provided a great opportunity for you to tell me what is important to your family and what you think Congress should be working on back in the other Washington.

In your letters and at town meetings you've told me that education is one of your top priorities; that you want to see our schools raise academic standards and lower class sizes. You've said you want Congress to pass a patients' bill of rights and bring about real campaign finance reform. And you've told me the right thing to do with a budget surplus is to pay down the national debt and shore up Social Security and Medicare.

In response to your voices, and with your help, I have carried that work to Congress. During this past year we've had some gratifying successes on local issues ranging from the proposed land exchange in Randle to providing funding for the Centralia Flood Control project and the Chehalis River Basin Investigation. My office got the U.S. Forest Service to plow Forest Road 99 in east Lewis County, which had been blocked by snow, and provided emergency help in the Town of Pe Ell to combat a serious problem with the community's sewage treatment plan.

You are a big part of the success that allowed us to retake this seat from the extremists in the last election and to do good work in Congress. Now I need your help again. I remember how difficult my first two campaigns were, and it's hard to forget that in 1998 I was the number one target in this nation. We just can't afford to rest. We've got to keep moving forward.

It's time to start the campaign in earnest, and I hope I can count on you to be at my side. I cannot express how deeply grateful I am for your continued support and faith in my work. I'm working hard to make sure we all win again in November.

## STATISTICS EVERY DEMOCRAT SHOULD KNOW

In 1992, Senator Patty Murray was on the ballot along with many fine candidates. Women voters turned out in droves, consisting of over 56% of the electorate. Democrats won seven of nine congressional seats, the State Senate and sixty-five seats in the State House.

In 1994 during the mid-term elections, 45% of the electorate were women voters. We lost six members of Congress and dozens of legislative seats in Olympia.

In 1996 during the second Clinton Presidential campaign with Gary Locke leading the state ticket, the turnout of women voters was at about 52% of the voters. Washington Democrats posted gains in congressional and legislative seats.

The 1998 election was the second midterm of the Clinton Presidency. Democrats were supposed to lose elections. But again with Patty Murray leading the ticket and Gov. Locke aggressively stumping for Democrats, over 53.5% of the electorate were women and Democrats won two congressional seats and a dozen legislative seats.

History teaches us what we must do in the 2000 election. We must get women out to vote in record numbers. And we have a potent team to do it. Governor Locke will be leading our ticket. A woman will be leading our US Senate ticket and Senator Murray will be available to stump for our candidates.

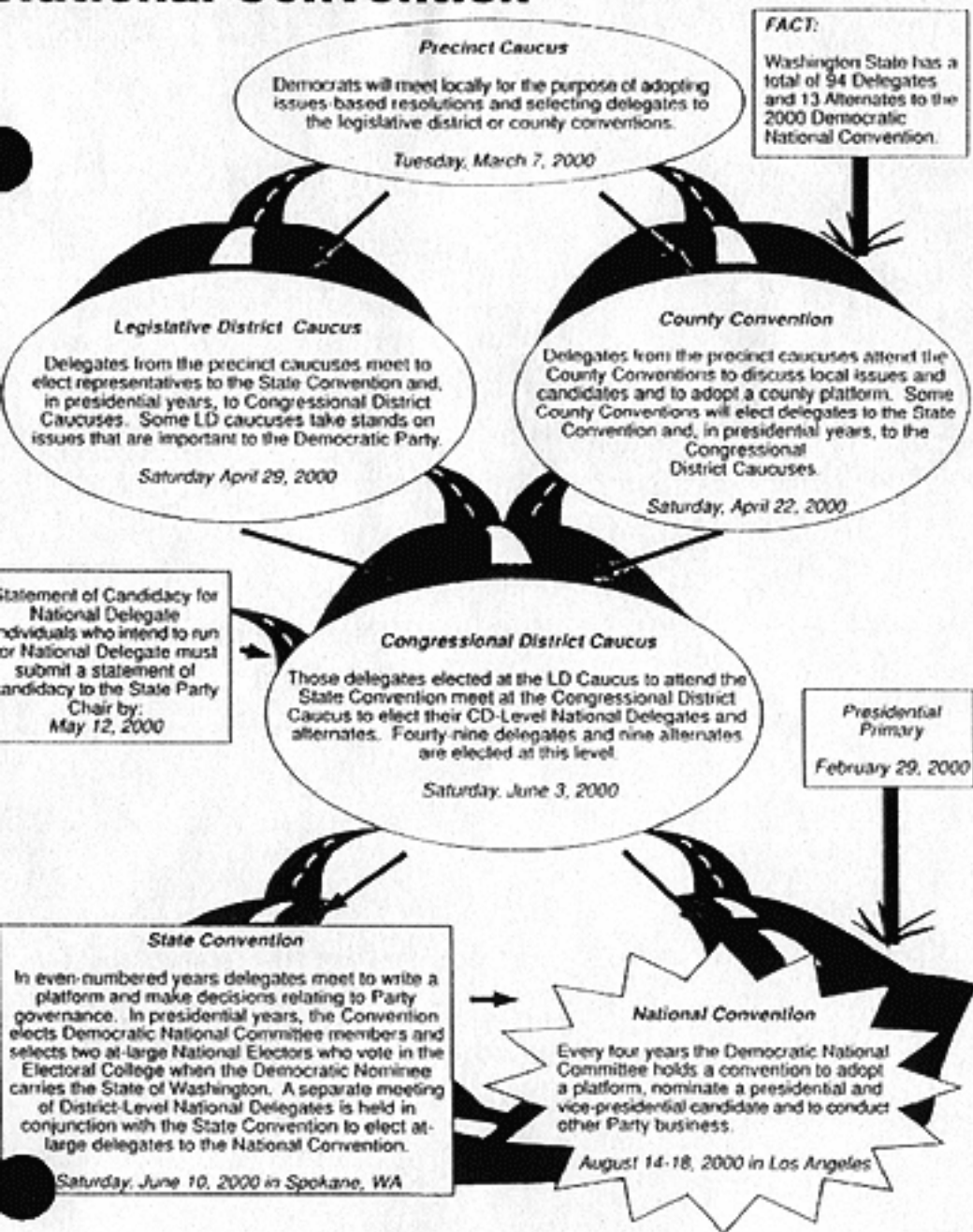

# Sample Ballot for February 29th Presidential Primary Election

Below is a copy of the sample ballot distributed recently by the Lewis County Auditor to those persons voting by mail. We want to remind everyone to vote -- by mail if yours is a mail-in precinct or you are voting absentee and in person if yours is a walk-up precinct. Those voting at their precinct polling place will have to choose whether you want a Democrat, a Republican or an Unaffiliated ballot and cast your vote using the specific ballot you requested. Those voting by mail will have to choose which ballot to vote (green for Democratic, blue for Republican or purple for Unaffiliated). It is important, if you are voting by mail, to vote with only one of the three primary election ballots. So, vote only under the Democratic Ballot, the Republican Ballot or the Unaffiliated Ballot. If you cast a vote on more than one ballot you will invalidate your entire ballot!
