## **Chronicle Editorials Go Beyond Opinions**

Everyone is entitled to their opinion and everyone has one, regardless of the subject. Newspapers are full of editorial pages with editorial boards printing their opinions of topics that are of interest to the readers they serve. Editorials are good to read because it usually makes people think about an issue in a way they hadn't. But when an editorial offers more than an opinion and crosses the line into making judgments on the supporters of one side or the other, the editorial does the readers a disservice by forming a conclusion for the reader.

The Merriam-Webster online dictionary defines editorial as "a newspaper or magazine article that gives the opinions of the editors or publishers." Recent editorials in the Chronicle have been stepping over this line.

A recent editorial, Power *Abuse Seems to Have Killed Bill on More Budget Review* (March 8, 2007) stepped over the line by drawing a conclusion and making a judgment on Democratic legislators. The

article talks about a bill proposed by 20th District Representative Gary Alexander, HB 1834, which would require a budget bill, capital, operating or transportation, be available for five days before a vote may be taken on the floor of the House or Senate. I don't think anyone would say that this is a bad idea. Honest, open, and accountable government is something the Democratic Party has sought for years, especially on a national level.

The editorial stated, "The steam rolling of the budget last year by House Democrats is an example of why Alexander's legislation is needed. They fast-tracked their budget proposal from a press conference to unveil it through the budget committee and out of the House in less than four days."

The Washington legislature web site shows a different timeline. It shows that the budget bill was introduced January 11<sup>th</sup>, heard in Ways and Means February 15<sup>th</sup>, passed out of the Ways and Means

## The Case For Impeachment

After listening to numerous people with credentials speak on the subject, such as Marjorie Cohn, Executive Vice President National Lawyers Guild, Benjamin Davis, legal scholar at Toledo University, Richard Falk, Professor of International Law at Princeton, Denis Halliday, former Assistant Secretary General of UN, Ann Wright, retired Lt. Col. who taught the rules of land warfare, veteran JAG officers, Iraq veterans, Antonia Juhasz, author of the "The Bush Agenda: Invading One Economy at a time", Elizabeth de la Vega, former prosecutor in the US Justice Department, author of US vs. Bush, et al, who make their cases on treaties such as the United Nations Charter, The Nuremburg Principles, The Geneva Conventions, United States criminal law, the Uniform Military Code of Justice, and the US Constitution, I am convinced that the current administration of the United States is a cabal of war criminals.

I have consulted the treaties, statute law, and the Constitution, too. Article VI, US Constitution: (in part) This Constitution, and the laws of the United States which shall be made in pursuance thereof; and all treaties made, or which shall be made, under the authority of the United States, shall be the supreme law of the land; and the judges in every state shall be bound thereby, anything in the Constitution or laws of any State to the contrary notwithstanding.

## **Chronicle Editorials, cont.**

Committee February 16<sup>th</sup>, and passed by the Senate on February 17<sup>th</sup>. The timeline in the House was very similar, being introduced February 20<sup>th</sup> with final passage on February 24<sup>th</sup>. It's not likely that these timelines constitute steamrolling. In fact, the last time the Republicans controlled both the House and Senate, 1997, the Senate budget bill was passed by Ways and Means, Rules and the Senate all in a single day. The House that year did something similar, only it took them two days.

The fact that this is not mentioned by the Chronicle is not what is troubling, however. The most troubling part of their editorial is that they lead the reader to make conclusions regarding why Alexander's bill never even received a hearing. They offer two conclusions, first that "Alexander is in effect a victim of majority party abuse of power." Second they propose that, "Perhaps the Democrats didn't want a Republican, Alexander, to receive credit for such obviously warranted legislation." So, according to the Chronicle, Democrats are either abusing their power or are jealous of Alexander to the point of sacrificing good legislation just to keep a Republican from getting credit for it.

Both conclusions offered by the Chronicle are pure speculation and do not take into consideration any of the normal politics that take place behind the scenes for weeks before a budget bill is even heard in committee. It's typical for the Chronicle to jump right to the most divisive, least likely conclusion.

In another editorial, *In Public Behalf, Any Efforts To Undermine Prosecutor Must Stop*, while posed as a question, the editorial board again leads its readers to a conclusion, "Are some in local law enforcement coordinating, in preparation for the next election, an improper relationship with their favorite, but losing, candidate for prosecutor to make the winner, Golden, look bad?"

Are you kidding me?

They suggest that the Lewis County Sheriff's office was slow to provide information and actually subverted a case against two individuals accused of vicious crimes in Packwood just to make the current County Prosecutor look bad. One line in the editorial offers that the Prosecutor does shoulder some responsibility for the case being dropped, but the editorial is just one continuous conspiracy theory.

Why the spin? Why does the Chronicle editorial board feel the need to make conclusions for their readers? Why not stop with an opinion on an issue?

In the case of the legislation requiring the five-day waiting period on budget bills, a more appropriate point for the editorial board to make is that to promote honest, open government, the legislature should pass a mandatory waiting period before taking action on budget bills. But this is not far enough for the Chronicle. They feel some need to drive the wedge deeper any time they can. On this issue, they do that by calling it an abuse of power on the part of the Democrats. They haven't even made the case that Alexander's bill is necessary and they don't talk about how Republican controlled legislatures have forced budget bills through with very little notice. It is always about trying to make Democrats look bad.

In the editorial on the prosecutor issue, the responsible point to make is that the prosecutor,

the Sheriff's office and defense attorneys need to do their jobs in order to prevent violent criminals from escaping prosecution. Suggesting that the Sheriff's office and defense attorneys are conspiring together to make the County Prosecutor look bad is inflammatory at best and libelous at worst.

To the Chronicle's editorial board: you have every right to your opinion, feel free to print that on your pages, but keep your misguided conclusions and conspiracy theories to yourself. These kinds of editorials do little to inform your readers – they only serve to perpetuate divisiveness through misinformation. Why do you keep printing them?

One of the more popular features of the Lewis County Democrats almost-nightly Headlines is the "Chronicle Watch." If you're not signed up, here's one example of what you've been missing:

## Congress Obligated to Renew Makeup for Lost Timber Sales

"Congress has an obligation to renew and continue the funding to replace lost timber revenue because it is Congress, with the environmental laws it passed in the past decade and longer, that caused the problem."

Congress OBLIGATED? We'd normally say "Bovine Scat!" But, since this is the Chronicle, we'll call it like we see it: Elephant Dung! Besides, we thought trees a renewal resource. You mean someone hasn't been replanting what they cut? Gosh...you told us they would!
