But over 800 of us were drawn into this thing last February, most of us for the first time. Did we think there were even 800 Democrats in Lewis County? Nooooo. And now some have become new PCOs. Some went to the County or State Convention. Some



have become Grassroots. Some are supporting the effort quietly. And some have continued doing what they'd been doing for years and years, volunteering with the Lewis County Democratic Party.

When asked, over 30 people said "Yes, We Can!" to the idea of Obama-Biden billboards on Hwy 5. They contributed \$700 for the project! That enabled us to rent extensive I-5 frontage (North of exit 68), put up four large Obama signs, as well as signs for Cutler, Rechner, Goldmark, Baird, and Gregoire. We were also able to place two additional double-sided Obama-Biden signs off Hwy 12 on donated frontage property. And we donated additional Obama signs for placement in the County.

OPUS: A Civics Lesson

The first hint we had that there was trouble brewing in the neighborhood was when our neighbor two doors up Mayberry towards the Chehalis River strolled over and remarked that the Port of Centralia was up to something huge--something that would result in all of our homes being flooded.

My first reaction was to smile politely, say nothing, and assume that the "powers that be" were watching over my home and my interests. After all, that IS the reason for government agencies, is it not?

By the 22nd of August, my interest had risen considerably. That day I learned a citizens' group had already gathered twice to discuss the OPUS Project at Port of Centralia #1 on Galvin Road without bothering to invite us...although neighbors in all four directions of our home were included.

By this time, the concerned citizens (which includes those of us on Ford's Prairie as well as folks up on River Heights) had:

- decided to hire attorneys,
- formed a non-profit corporation of which we are allegedly members and therefore liable for some of those afore-mentioned attorneys' fees,
 - •generally riled up a whole lot of people.

A public meeting with Centralia Mayor Tim Browning and Port attorney Sandy Mackie was held on September 3rd. We went because we wanted answers. From what we were being told (through the grapevine) by those now openly opposed to the project, NOTH-ING about it had been done legally or openly.

Frankly, neither the mayor nor Mackie was saying anything to answer my questions or concerns, so I finally spoke up and interrupted the attorney. My con-

cerns that evening were increased chance of flooding on our street, air and water pollution, congestion on major arterials on our end of town, and the apparent lack of open, transparent government on the part of the Port of Centralia.

Following that meeting, we began getting nearly daily e-mail updates from one of the leaders of the resistance. I was also suddenly being informed of Port of Centralia meetings and e-mailed the agendas for those meetings.

Because of the volume of anti-OPUS information we were receiving, I decided to begin asking questions on my own. I met a couple of times with a city official, attended a Port Commission meeting, spoke with members of the media who had been investigating the situation, studied the plans for the project, and drove over and really looked at the site.

Five weeks later, by the time OPUS and the Port hosted another public meeting, I was a supporter of the project. For the first two hours that evening, a very professional presentation was made, including peer reviews of both the flood study and traffic study which had originally been done during the permitting process. I heard nothing which caused me any concern.

When public comments were requested, I announced I no longer had any objections. Instead of the cheers and applause of that first meeting, my comments were now greeted by a deafening silence as I made my way back to my seat – except,

Energy production in Lewis County?

Exciting local trends in energy technology

Where is energy production going? In the Pacific Northwest, we have been blessed with fairly cheap electricity thanks to the hydro production and capacity, but times are changing. As we experience tremendous growth, especially in the Puget Sound region, the demand for energy is also growing. So where do we go for electrical power?

There are some interesting and innovative business folks and inventors working in our region. Here in Lewis County, one person is working on a more efficient solar panel. It has been reported that he has been successful in coming up with a solid design that will improve efficiency and possibly open the doors to more solar panels being used for housing and business.

Wind and wave power is being studied off the coast of Grays Harbor. On days the wind isn't blowing, the wave power will still produce electricity. There are many wind turbines operating in Europe and the feasibility study for their potential in our area is well under way. They would be placed up to ten miles off the coast.

The same company that is looking at wind and wave power has designed a paddle box that can be placed in an irrigation canal and produce energy. They are working with a winery in eastern Washington to determine if they can produce all of the winery's electrical needs with this device.

In west Lewis County a company is working with Weyerhaeuser near Pe Ell to install our first wind farm in this area. Companies are also looking at another area in west Lewis County, as well as locations in Pacific County and Grays Harbor. While attending the Northwest Green Expo, I spoke with a fellow who has invented a smaller system of wind turbines. They are much smaller and would have four or five turbines on a single stand, and could be used for home generation. It wouldn't be a huge producer of power, but with improved technology, it could have potential.

Tidal power is another area being studied in Pacific County in a partnership with the PUD and a private company. I recently had the pleasure of attending a tidal power conference in Seattle where a UK trade mission made a presentation. They have

made substantial progress in developing tidal power and are working on even more efficient technologies. Snohomish PUD has 7 permits for feasibility studies in Puget Sound. They are approaching it with 6 or 7 state agencies and several federal agencies. The issues they are considering are impact on marine life and impact on the bottom where these devices need to be anchored.

These are just a small sample of the things happening with electrical power production. On the fuel side, there are some exciting things happening as well.

Where will the work force come from to meet these new demands? That's where a WIRED grant from the Department of Labor comes into play. It is a three year project that is divided into four sectors:

- Green Construction
- Energy/Technology
- Manufacturing
- Innovation

The grant creates an industry, labor, and education led training program with the latest technology. Programs will be developed for incumbent worker training, dislocated worker training and K through 12 opportunities in these industries. This work force training and availability will be the cornerstone for a new kind of economic development in a five county region including Lewis County.

Newspapers in Key Battlegrounds Flipping for Gregoire

SEATTLE - As political watchers everywhere anxiously await the Seattle Times' endorsement of Republican Dino Rossi for his courageous stance on the estate tax, key newspapers elsewhere are either flipping their endorsements from 2004 or calling out Republican Dino Rossi for his relentlessly negative, substance-free campaign for governor. In the last two weeks, flagship newspapers in two key swing counties that will play a pivotal role in deciding the 2008 gubernatorial race -- The Tacoma News-Tribune in Pierce and The Columbian in Clark -- have switched their 2004 endorsement of Republican Dino Rossi and are now backing Gov. Gregoire.

- 1. Pierce County is a critical battleground in the race between Gregoire and Rossi. In 2004, Gov. Gregoire received just under 47% of the vote, around 4% behind Republican Dino Rossi. In the 2008 primary, she received 47.51%, finishing just ahead of Rossi in a very tight race.
- 2. Clark County is also a critical battleground. In 2004, Gov. Gregoire received 44.7% of the vote, 8.04% behind Republican Dino Rossi. In the 2008 primary, she got nearly 46%, which was only 1.31% behind Rossi.
- 3. These endorsements could make a real difference, giving Gregoire a key boost as voters

begin casting ballots in just 2 days.

Meanwhile, newspapers that endorsed Gregoire in 2004 are encouraging voters to give her 4 more years, based on her record of getting real results in tough times for Washingtonians. Rossi's relentless negativity and evasion, delivered with his used-carsalesman smile, have drawn less-than-kind reviews.

The Olympian -- who called Rossi "a slick carnival hawker" -- argued:

"[Rossi] promises not to cut education, not to cut programs for vulnerable citizens, not to raise taxes and, in fact, he wants to further deplete the general fund budget by moving money into transportation projects and securing additional dollars for education. Where's he going to get the money? Rossi refuses to be specific, offering only to go through the budget line-by-line. In other words, voters are going to have to wait until he's in office to find out which state programs are gutted, whether teacher and state employee salary increases will be delayed or if entire state programs will be eliminated. That's a huge gamble - a gamble this editorial board is not willing to take."

The Seattle P-I argued that Gregoire was "a clear choice" and criticized Rossi for his evasion and un-

readiness to be governor:

"[Rossi's] avoidance of questions about his social conservatism, his unrealistic transportation ideas and even his unwillingness to be labeled Republican on the ballot all warn there's a lot about how Rossi would govern that most of us, including perhaps the candidate, would learn only after he took on the job."

The economy looked bleak. After years of Republican rule in the White House, uncertainty with banks finally took its toll with house foreclosures and bank closures. In addition to huge majorities in both houses of Congress, the 1932 election brought Washington State Legislative majorities in the House and Senate. The numbers were truly astounding.

In the State House of Representatives, Democrats went from 62 to 70 members and the Senate from 1 member to 25! While an effort to retain a graduated income tax passed by the voters failed in 1934, significant changes to workers compensation and minimum wage protections consistently showed what

progressive action can accomplish.

Even Lewis County was not immune to the Democratic sweep. The 1932 election gave all 3 legislative seats to Democrats – the Senate to Dr. D.O. Nugent and the House seats to T.R. Donahoe (a long-time Lewis County Democratic family) and Charles Gessell. It wasn't until 1938, and after FDR's Supreme Court "packing" controversy, that the legislative seats were lost to the GOP. They did not return consistently to the Democratic fold until the 1960s with Gary Odegaard, Bud Kalich and Elmer Jastad.

The point of this historical journey is to show that we have walked a similar path before. With all respect to Robert Schuller, from tough times great things can come. We've shown it during the FDR era – and we will see it again in the Obama era to come from Washington DC to Washington AC (alternate coast), and even right here in Lewis County.
